Trustee Responsibilities and Duties

The organisation is governed by a volunteer Board of Directors who provide support and guidance to the team, act as ambassadors for our work, uphold our values, and are responsible for:

- Contribute actively to the role of the Board in giving coherent and relevant strategic direction to the organisation, approving overall policy, aims and objectives and evaluating performance against agreed targets.
- Always act in the interests of FBA and safeguard the good name and values of the organisation.

In addition to the above statutory duties, each trustee should use all the skills, knowledge and experience they have to help the Board and team reach sound decisions through contributing to discussions, providing advice and guidance.
